GEORGIA, DOUGHERTY COUNTY:

The present name of the corporation is: CHEHAW
COUNCIL OF BOY SCOUTS OF AMERICA, INC.

2.

The members of Chehaw Council of Boy Scouts of
America, Inc., a non-profit corporation organized and existing
under the laws of the State of Georgia, did on the 27th day
of November, 1984, adopt an amendment to the Articles of
Incorporation of said corporation for a change of the corporate
name from CHEHAW COUNCIL OF BOY SCOUTS OF AMERICA, INC. to
SOUTHWEST GEORGIA COUNCIL OF BOY SCOUTS OF AMERICA, INC.

These Articles of Amendment were authorized on
November 27th, 1984, by a vote of the membership, the vote

to vote, and 19 members having voted for the amendment.
